### Resignation of Councilmember Nanette Fish

Having just finished her year as Mayor we are sorry to see her leave and thank her for her years on the City Council. ### Temple City Unified School District Retirements

### COVID-19 Among Us

As of April 28, 2020, there are 48 reported cases of COVID-19 in Temple City and 7 deaths. In Los Angeles County there are 22,485 reported cases and 1,056 deaths. In California there are 46,500 reported cases and 1,887 deaths. In the United States there are 1.06 million reported cases and 61,361 deaths, and in the world, there are 3.19 million reported cases and 227,000 deaths.

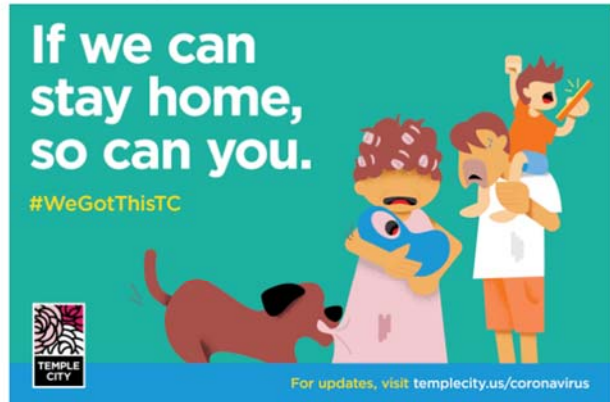
## City Signs
